WHEREAS, the Town Board shall review the Fee Schedules on at least an annual basis for the purposes of adjusting and updating the fees charged by the Town, and any amendments or additions thereto may be made by Resolution, and

WHEREAS, the fees set forth in the Fee Schedules shall supersede any fee established elsewhere in the Town's Code of Ordinance for the same charge. If a fee is set forth elsewhere in the Town of Lake Mills Code of Ordinance or via a Resolution, and there is no corresponding fee set forth in the attached Fee Schedules, the fee set forth elsewhere in the Code of Ordinance or the Resolution shall control until such time as a fee for the same charge is established in the Fee Schedules, and


